#### **HRMFFA Update - RDML Quigley**

General Assembly passed a State version of Federal DCIP program of \$5M for localities supporting installation; Governor support for income tax forgiveness for portion of military retired pay to retain veterans in commonwealth; President submitted proposed FY 23 budget to include 4.6% pay raise for active duty in addition to funding for ship building/repair

Craig announced retirement and step-down position in June and relocating to Phoenix, AZ. Recommend Rick Dwyer for his relief and search for new Deputy.

Rep Luria – provided remarks on Defense Budget and effort of adding \$29M, ship decommissioning and commissioning efforts.
