## SPECIAL MEETING

- 1. Approval of a resolution authorizing the dedication of approximately 19 acres in the Innovation Park for Acoustical Sheetmetal Company LLC
  - Laura Hayes shared a press release and presentation that is attached to these minutes
    - Lisa Murphy asked the value of the land
      - o Laura shared the value is \$90,000 per acre
    - Director Taylor Adams shared
      - o This property has a Dominion Easement that runs down the middle of the parcel
      - o This land has been held by the City for more than 25 years
      - o Purchased by the City for \$1,250 per acre

- o The Commonwealth Opportunity Fund grant announced by the Governor today must be matched dollar for dollar
- We decided to hold on to the \$900,000 cash and offer the land as a match to the COF
- City Attorney Alex Stiles shared this was briefed to the City Council and they were supportive of this approach
- Lisa Murphy stated they will be held to the restrictions and guidelines for the design
- Council Member Rosemary Wilson shared the City of Virginia doesn't have the Machinery and Tool Tax here which helps
