- 6. VBDA Priorities.
  - Commissioner William Brunke asked if there could be a discussion on the employee retention and expansion incentives to address the audit findings
    - i. Director Adams asked if this could wait until our City Attorney Alex Stiles could be present for that conversation
  - Brunke also asked the status of quarterly reports and payment is due from Vanguard Landing.
    - i. City Auditor Lyndon Remias announced that their payment was due on February 14, 2022.
    - ii. Deputy City Manager, Taylor Adams announced that there have been quarterly reports and their initial payment had been received, but there have been no indications their payment would not be made in February.

- iii. Adams also asked if the Board could wait and have the conversation on Vanguard Landing with the City Attorney Present.
  - 1. The Board Members agreed.
- iv. Chair Lisa Murphy asked if there could be a reminder statement sent out to Vanguard reminding them of their payment being due on February 14, 2022
- 7. Chair Lisa Murphy announced that Board Member Dorothy Wood was unable to attend today's meeting as she has been under the weather.
- 8. Director's Report
  - Kathy Warren announced the DIP matching grant of up to \$10,000 has been approved for a second round, the name has been changed to Facade Matching Grant and going live today.
  - Taylor Adams thanked the members for their vote on the CDA for Atlantic Park and that 100% of these funds will be going to fund public infrastructure.
  - Taylor Adams announced that Letitia Langaster had been with the City for 5 years and presented her 5-year service pin.
