2. Approval of the City of Virginia Beach Development Authority FY2022-2023 Annual Report to City Council presented by Interim Director Charles Rigney.

Discussion:

Chair Lisa Murphy shared the Citizens Committee on Boards and Commissions Final Report that was adopted in December of 2022 enforcing meeting attendance is a relatively new policy as it relates to the inclusion of member attendance in the City Council annual report. Chair Murphy encouraged Commissioners to see her after the meeting to review and confirm any absences that may need to be updated per the new policy. She also mentioned wanting to include EDIP grants and new examples of projects where Commonwealth opportunity funds contributed to having a much bigger economic impact. She also thanked Katrina Flowers, Emily Archer, Kathy Warren and Alex Stiles for the tremendous amount of time they have spent working to review contracts and make disbursements for the Atlantic Park project.

3. Approval of motion to appoint Interim Director Charles Rigney as Assistant Secretary of the City of Virginia Beach Development Authority presented by Senior City Attorney Alexander Stiles.

FINANCIALS

4. Review of Financial Statements for June and July of 2023 presented by Katrina Flowers.

Discussion:

Chair Lisa Murphy asked if a trend line was included showing the appropriations the Authority receives each fiscal year based on the cigarette tax. Katrina Flowers confirmed the trend line was included and noted the significant \$200,000 decrease due to declining cigarette sales. Chair Murphy also asked the three present City Council representatives if the tax money from vaping, if it is included with the legalization of marijuana, could be included with the appropriations the Authority receives since there is a noticeable decline in cigarette sales. Vice Mayor Wilson responded that this was included in the legislative package last year. Chair Murphy is hopeful this will help with the EDIP grant funds.

CONTRACTS

5. Approval of an amendment to the Town Center Block 11 lease presented by City Attorney Alexander Stiles.

Chair Lisa Murphy announced this item was still not ready and would be tabled for this month.

6. Approval of a Forbes Candies assistance request presented by Emily Archer.

Discussion:

Commissioner Taylor Franklin asked what would happen if they don't build the building and if the company would get their money back if they didn't build the building. Emily Archer explained all these in-kinds would happen during construction. Senior City Attorney Alexander Stiles clarified that the company would not get the money back, but the Authority would get the improvements. Chair Lisa Murphy asked how far along the construction process was on Global Way and if it had started. Ms. Archer stated that the pond was about 80 percent complete, the utilities have just begun for the water and sewer line, and they are hoping to have the road under construction in 2024. This infrastructure would not only serve Forbes Candies but five other parcels in the Corporate Landing Business Park. Commissioner Michael Standing asked if the company was paying the same price per acre. Ms. Archer confirmed that was correct. Commissioner William Brunke asked Ms. Archer to confirm that the second and third item requests on slide 6 of the presentation were at no hard dollar cash cost to the Authority and she confirmed that was correct. Commissioner Brunke also asked if there were other situations in Corporate Landing Business Park or Innovation Park where the Authority provided development fees for developers who oversaw part of the infrastructure construction. Ms. Archer articulated not currently and that this would be new for Corporate Landing Business Park. Chair Murphy stated that this section of the Corporate Landing Business Park did not have any of those improvements to begin with. If they could go in where there was preexisting infrastructure that would be one thing but the timing of their construction and the Authority's construction of the infrastructure is such that it makes sense to have the company manage that project for the Authority because we are using the same contractors. They are just managing the process. Commissioner Brunke asked Ms. Archer to confirm that the developers are just managing the connectivity of the pond, the two utility lines and one water line of the construction on the Authority's behalf and she affirmed that. Chair Murphy stated the assistance request was basically a credit against the purchase price and the Authority was not coming out of pocket.

ADMINISTRATIVE INFORMATION

7. VBDA Priorities: Commissioner G. Weissenseel

Discussion:

Chair Lisa Murphy asked Commissioner Guenter Weissenseel to share updates from his recent trip to Germany and his efforts to help the Authority determine how best to attract, train and retain employees for the City's manufacturing companies. Commissioner Weissenseel shared that 23 people went on the trip including five mayors and five presidents from the area. They were able to visit STIHL's global headquarters. Stihl currently has about 200 apprentices and 20,000 employees manufacturing six to eight million chainsaws a year with \$5.4 billion in sales. From there, they visited schools wherein the college presidents were asked detailed questions about how the system works, how to get trained, and what can be included in our systems to make it better to train more people. There will be a follow-up meeting in two weeks where trip attendees can discuss action items. The group also visited IMS Gear's headquarters. IMS Gear has about 170 apprentices in Europe. There was an open forum to discuss how the whole system worked, pros, and what can improve. The goal now is to find a real pathway to accessing available workforce dollars to implement desired trainings.

8. VBDA Members: L. Murphy

Discussion:

Chair Lisa Murphy asked Commissioner William Brown and Commissioner Guenter Weissenseel to serve on the nominating committee and give a report next month. She also announced the end of Commissioner Nneka Chiazor and Commissioner Joseph Strange's terms for the Authority. She read both commissioner's resolutions and thanked them for their service. Commissioner Strange was absent.

9. Director's Report:

Discussion:

Interim Director, Charles E. Rigney, gave a presentation update on Projects Beach and Door Cost Participation. Chair Lisa Murphy asked if a multiuse trail or sidewalk along the Southeastern Expressway alignment would be created where the new road is going. Mr. Rigney confirmed that was correct. Councilman Worth Remick asked if the \$22.5 million for infrastructure improvements would go towards opening up more industrial land sites. Mr. Rigney stated should the future development opportunity come in, there is some land there that could potentially become opportunities for economic development. Commissioner William Brunke asked where the anticipated employees were coming from for these new jobs at \$17/hr. Mr. Rigney shared that Councilman Chris Taylor asked the same question during the presentation to City Council. He said there's a number of people that work two and three jobs to generate the \$17-\$20/hour wage difference. These jobs are coming with a full benefits package as a way to move up in working shift work.

Chair Lisa Murphy moved to recess into a closed session.
